- ☐ Proof that you own the installation. This includes:

- A death certificate for the previous owner.

And one of the following:

- A solicitor's letter stating your ownership.
  - A will showing you're the beneficiary of the estate.

- ☐ A photo of your generation meter and export meter (if you have one), clearly showing the serial numbers and up-to-date meter readings.

An export or smart meter measures the amount of electricity that is exported to the National Grid.

If you **DO NOT** have an export or smart meter and your installation is 30kW or less, you'll receive deemed payments. These are estimated payments decided by the government regulator, Ofgem. For wind and solar, it estimates that you'll export 50% of what you generate back into the National Grid. For hydro, it estimates you'll export 75%.

If you **DO** have an export or smart meter installed we'll contact you for readings each quarter, and you'll receive metered export payments.
